CHAPTER 22: ORDINANCE TO APPOINT THE TOWN CLERK TO THE BOARD OF REVIEW

22.01Title and Purpose

The title of this ordinance is Town of Washington Ordinance to Appoint the Town Clerk to the Board of Review. The purpose of this ordinance is to authorize the Town Board to appoint the person holding the appointed office of Town Clerk to serve on the Board of Review as a voting member provided the person is an elector of the town.

22.02 Authority

The Town of Washington has the authority to enact this ordinance under its village powers under $\S60.22$, Wis. Stat. and the specific authority under $\S70.46(1)$ Wis. Stats., $\S70.46(1m)$ Wis. Stats., and 70.46(1m)(b), Wis. Stats.

22.03 Regulations Governing Procedures for Board of Review

Pursuant to Section 70.46(1) Wisconsin Statutes, the Board of Review is made up of the Town Board Supervisors and the Town Clerk. The Town of Washington Town Board desires to have the person holding the office of appointed clerk to serve on the Board of Review as a voting member, provided the person is an elector of the town.

Such appointment shall remain in effect until the person holding the office of appointed clerk is no longer an elector of the town.

22.04Severability

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful, or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

22.05 Adoption of Ordinance

This ordinance, adopted by a majority of the Town Board with a quorum present and voting and proper notice having been given, formally adopts the Town of Washington Ordinance to Appoint the Town Clerk to the Board of Review.

This ordinance repeals and replaces all ordinances pertaining to the appointment of members to the Board of Review previously adopted by the Town of Washington.

22.06 Effective Date

This ordinance is effective upon adoption and publication or posting. The Town Clerk shall properly post or publish this ordinance as required under §60.80 Wis. Stats.
